Location: Dickinson Co., KS

Planting Date: N/A: Third year (10-12" tall at application)

Plot Size: 10 ft. x 20 ft.

Experimental Design: Randomized Complete Block; 4 Replications

Information: Sprayed with hand sprayer delivering 20 gal/acre at ca.30 psi on 22

April 2009.

Phytotoxicity: None noted

Evaluation: 10 stems/treatment / replication (40 total) randomly selected,

shaken into 1 gal. white container and counted on 25 (3 DAT), 28 (6 DAT) Apr, and 2 (11 DAT) May, 2009. (3 DAT), (6 DAT), and

(11 DAT)

DAT = Days After Treatment

Special Notes: Pre-treatment counts conducted on 22 Apr, 2009 had 8 weevil

larvae / 10 stems i.e. ca. 1/larva stem. On 26 April, this field received 4.5 inches of rain and experienced 60+ mph winds.

Weather at Time

of Treatment: 50°F 10-15 mph winds
